

**Acknowledgement and Assumption of Risk.** I acknowledge the contagious nature of the Coronavirus/COVID-19. I further acknowledge that NBBI cannot guarantee that I and/or any minor child of whom I am a parent or guardian will not become infected with COVID-19 if I/we attend NBIC Committee Meetings, and I fully appreciate both the known and unknown potential dangers of attending NBIC Committee Meetings. I understand exposure to COVID-19 may result in quarantine requirements, serious illness, disability, and/or death for me and/or any minor child of whom I am a parent or guardian in attendance with me and/or persons who are exposed to COVID-19 as a result of contact with me or them. **Severability.** I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE.
